E-Boiler Legal Disclaimer and Liability Waiver

Grakksaw, LLC (hereinafter referred to as "Grakksaw," "we," "us," or "our") provides the E-Boiler product (the "Product") for use in self-taxidermy processes, including skull boiling and maceration. By purchasing, using, or otherwise accessing the Product, you (the "User," "you," or "your") acknowledge that you have read, understood, and agree to be bound by this Legal Disclaimer and Liability Waiver (the "Waiver"). If you do not agree to these terms, do not purchase or use the Product.

This Waiver is intended to be a complete and unconditional release of liability to the fullest extent permitted by law. It applies to all users, including but not limited to purchasers, operators, and any third parties who may come into contact with the Product.

1. Important Safety Warnings and Risks

The E-Boiler is a high-wattage, 120V electric-powered device designed for heating water to process animal skulls through boiling or maceration. Improper use can result in serious injury, death, property damage, or other harms. You must read and follow all instructions provided with the Product, including any user manual or safety guidelines.

Key risks associated with the Product include, but are not limited to:

Electrical Hazards: Risk of electric shock, short circuits, or fire due to exposure to water, damaged cords, improper grounding, or use in wet environments. Always use a grounded outlet and avoid contact with water while the device is plugged in.

Thermal Hazards: Water can reach temperatures up to 212°F posing risks of severe burns, scalding, or steam-related injuries. Never touch hot surfaces or submerge body parts in heated water.

Biological Hazards: Maceration involves bacterial decomposition of organic material, which may produce harmful bacteria, odors, toxins, or pathogens (e.g., risk of infection from handling animal remains or contaminated water). Use in a well-ventilated area, wear appropriate protective gear (gloves, masks, eye protection), and dispose of waste in accordance with local health and environmental regulations.

Mechanical Hazards: Sharp edges on animal skulls, moving parts (e.g., lids, guards), or improper securing of skulls could lead to cuts, punctures, or equipment failure.

You acknowledge that self-taxidermy involves inherent dangers and that no product can eliminate all hazards. You represent that you are in good physical and mental health to use the Product and that you have the necessary skills and knowledge to operate it safely.

Any disputes arising out of or related to this Waiver or the Product shall be resolved exclusively through binding arbitration in Jefferson City, Missouri under the rules of the American Arbitration Association, or in a court of competent jurisdiction in Cole County, Missouri if arbitration is unenforceable.

8. Severability and Entire Agreement

If any provision of this Waiver is held to be invalid or unenforceable, the remaining provisions shall remain in full force and effect. This Waiver constitutes the entire agreement between you and Grakksaw regarding the Product and supersedes all prior agreements or understandings.

Grakksaw reserves the right to modify this Waiver at any time. Continued use of the Product after modifications constitutes acceptance of the updated terms.
